Basic returns are of the complexity typically associated with a simple taxpayer and have no more than 5 basic tax slips. A tax return including complex forms, complex tax slips, or large volume of transactions is not a basic tax return. For example, income tax returns that include capital gains/losses, foreign tax credits, employee stock options, report transactions involving hedging, swaps, cryptocurrency, or other financial instruments, returns including rental properties, sole proprietor, or self-employed activities or returns with more than 1 partnership (form T5013s) are not considered basic returns. Tax returns which are more than 1 year late and/or require additional tax planning are not basic. Hourly fees are applicable for bookkeeping services, cost calculations and foreign exchange calculations. Completed worksheets are required. For non-basic returns, we will provide an estimate cost of service based on your information provided.

All clients have access to the online Portal with CCH Wolters Kluwer. Allowing us to work together virtually and securely from anywhere, globally. EFILE service is included for most Canadian tax returns prepared by the Firm and includes notification of CRA EFILE acceptance.
